## Novedo acquires the roofing specialist Helsingborgs Byggplåt and Bra Tak Entreprenad Skåne with a combined turnover of approximately SEK 120 million

Novedo Holding AB (publ), a niche industrial group within Industry, Infrastructure and Installation & Services, has today signed an agreement to acquire the roofing specialist Helsingborgs Byggplåt AB and the wholly owned subsidiary Bra Tak Entreprenad Skåne AB. The companies' combined turnover for 2022 amounted to approximately SEK 120 million. Closing is expected to take place in Q1 2023.

Novedo continues to grow the Group's portfolio of B2B companies with a sound corporate culture, developed niche positions and proven business models and has today signed an agreement to acquire the well-established company Helsingborgs Byggplåt and the wholly owned subsidiary Bra Tak Entreprenad Skåne AB. The main owner and seller is CEO Jimmy Wallberg who remains in his role after the sale and also becomes a shareholder in the Novedo Group.
