## Novedo expands outside of Sweden – acquires Danish Nordkabel A/S with annual net sales of about 315 MSEK

Novedo Holding AB (publ), a privately owned industrial group within industry, infrastructure and installation & services has today acquired the Danish company Nordkabel A/S ("Nordkabel"), the company's first acquisition outside of Sweden. Nordkabel, which will be part of Novedo's Infrastructure segment, performs installations and service work, primarily in electricity networks, fibre and water, and has a strong and stable customer base exclusively in B2B including well-known companies and customers in the public sector. The company reported net sales of DKK 215 million and EBITA of DKK 32.5 million (corresponding to approximately 315 MSEK and 48 MSEK) for the financial year ending on 30 June 2022. Nordkabel is expected to be consolidated in the Novedo Group during Q4 2022.

Novedo is pleased to announce that it has acquired Danish company Nordkabel, its first acquisition outside of Sweden. The main owners and sellers are CEO Henrik Hassing and Operations Director (afdelingsleder) Björn Christiansen who will retain their positions within Nordkabel following the acquisition along with other executive decision-makers. Henrik and Björn will also be part-owners in the Novedo Group.

Nordkabel with about 200 employees was founded on 1988 and is today located in eight Jutlandic locations, of which the head office is based in Aars (near Aalborg). The company carries out installations and maintenance foremost within electricity networks, fibre and water. Nordkabel has a strong and stable customer base exclusively within B2B consisting of long customer relationships, often via framework agreements, and close collaborations with municipalities, private and public energy suppliers and telecom companies. Seasonal variations are managed by balancing new installations with maintenance work. For the financial year ending on 30 June 2022, Nordkabel reported net sales of DKK 215 million and EBITA of DKK 32.5 million (corresponding to approximately SEK 315 million and SEK 48 million respectively).
