

# Novedo acquires Falks Markentreprenad with annual sales of approximately SEK 120 million

Novedo Holding AB (publ) has today signed an agreement to acquire Falks Markentreprenad AB with annual sales of approximately SEK 120 million and good profitability. The company was founded in 1965, is based in Vårgårda outside Gothenburg, and has approximately 30 employees. The company is intended to be consolidated into Novedo during Q2 2025.

Falks Markentreprenad performs various types of groundwork with a focus on foundation work, water and sewage work and infrastructure projects in the Västra Götaland region. For the 2024 financial year, net sales amounted to approximately SEK 120 million with good profitability. The company works primarily with regional construction companies as well as the state and municipalities.

"I am very pleased that Falks Markentreprenad, which has been successfully operating for 60 years, is now becoming part of Novedo. It is a well-managed company with a long history and a strong regional market position. I am impressed by, among other things, the high level of technical expertise within the company and the focus on quality that characterises project management, consulting and customer service.
